French prosecutors have opened a rape investigation into Gérard Depardieu, and after his recent "retirement," police are going to "go through his entire trash." The actor is accused of raping a 23-year-old woman at his hotel suite in Paris. "We know of the charges that have been filed," said Paris' prefect for security, Laurent Nuñez, who added, "We are going to go through his entire trash." The investigation focuses on an alleged assault that took place at the Paris Ritz-Carlton hotel in April 2012. The victim had apparently not been on the set of The Artist, and she was intoxicated. "[She] awoke in the morning naked in a bed," reads the complaint. "She recognized [Depardieu], who said to her, 'Come with me in the shower.' [She] then followed him." After showering, the accuser claims Depardieu returned her to the hotel room and forced himself on her. She left the next day, went to police, and waited for three days before filing her complaint, fearing it would negatively impact her career. The prosecutor is also seeking to imprison Depardieu for one year and a fine of €75,000. Depardieu's reps told reporters, "We have no comment."
